Bloomberg U.S. Aggregate Bond Index: Bloomberg U.S. Aggregate Bond Index is an unmanaged index considered representative of the US investment-grade, fixed-rate bond market.

Bloomberg U.S. Government/Credit 1-3 Year Index: Bloomberg US 1-3 Year Index measures the performance of investment grade, US dollar denominated, fixed-rate, taxable corporate and government-related debt with 1 to 2.9999 years to maturity. S&P Target Date Retirement Income Index: The S&P Target Date Retirement Income Index is designed to serve as the ultimate endpoint for all assets tracking other indices in the S&P Target Date Index Series. When an index in the S&P Target Date Index Series is retired, any funds tracking that index will have the assets rolled into a fund that tracks the S&P Target Date Retirement Income Index.
