VALIC's Fixed-Interest Option features interest rate guarantees that include: (i) a lifetime minimum interest rate of 1.00% set at the time the contract is issued; (ii) an annual crediting rate of 1.65% for calendar year 2017; and (iii) in the company's discretion, a current crediting rate, declared no more frequently than every 90 days, and equal to or greater than the annual crediting rate. Each rate is credited on a daily basis at an annual effective rate and uses a portfolio interest crediting method in which all deposits, as well as credited interest, receive the same crediting rate regardless of date of deposit. VALIC's interest-crediting policy is subject to change, but any changes will not reduce the current rate below the contractually guaranteed minimum or money already credited to the account. All guarantees are backed by the claims-paying ability of The Variable Annuity Life Insurance Company.
