

## **SUMMARY ANNUAL REPORT FOR LEHIGH VALLEY HEALTH NETWORK, INC. 401(K) SAVINGS PLAN**

This is a summary of the annual report for the Lehigh Valley Health Network, Inc. 401(K) Savings Plan, EIN 22-2458317, Plan 004, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$14,477,794. These expenses included \$283,275 in administrative expenses and \$14,194,519 in benefits paid to participants and beneficiaries. A total of 4069 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$157,121,753 as of December 31, 2022, compared to \$195,263,689 as of January 1, 2022. During the plan year, the plan experienced a decrease in its net assets of (\$38,141,936). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$23,784,511), including employer contributions of \$2,202,120, employee contributions of \$8,582,078, other contributions of \$806,739 and earnings from investments of (\$34,545,099).

### **Paperwork Reduction Act Statement**
