

SUMMARY ANNUAL REPORT FOR LEHIGH VALLEY HEALTH NETWORK, INC. 401(K) SAVINGS PLAN

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the LEHIGH VALLEY HEALTH NETWORK, INC. 401(K) SAVINGS PLAN, EIN 22-2458317, Plan 004, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), Code section 401(m), participant-directed brokerage account, automatic enrollment, default investment account, pre-approved, controlled or affiliated service group member, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$12,141,614. These expenses included \$278,990 in administrative expenses and \$11,862,624 in benefits paid to participants and beneficiaries. A total of 3614 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$184,957,408 as of December 31, 2023, compared to \$157,121,753 as of January 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$27,835,655. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$39,977,269, including employer contributions of \$1,976,235, employee contributions of \$8,007,074, other contributions of \$753,116, earnings from investments of \$28,409,713 and other income of \$831,131.
