

**SUMMARY ANNUAL REPORT
FOR NORTHEASTERN PENNSYLVANIA HEALTH CORPORATION 401(A)
PLAN**

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the NORTHEASTERN PENNSYLVANIA HEALTH CORPORATION 401(A) PLAN, EIN 22-2458317, Plan 007, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, profit-sharing, ERISA section 404(c), total participant-directed account, default investment account, pre-approved, controlled or affiliated service group member, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$551,286. These expenses included \$21,349 in administrative expenses and \$529,937 in benefits paid to participants and beneficiaries. A total of 600 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$8,232,033 as of December 31, 2023, compared to \$7,028,828 as of January 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$1,203,205. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,754,491, including employer contributions of \$535,313 and earnings from investments of \$1,219,178.
